Be advised of the following for this C-141:

The API number listed on this form C-141 is for a well bore that is P/A, with OCD records indicating POGO as operator of record. The C-141 will be entered under this API number but will reflect OGRID number 16696, which is for OXY USA Inc. This action requires nothing on your part, as it is not uncommon to have a CTB at a plugged well site. This is for clarification only.

When release volumes are reported as "TBD", OCD data entry will reflect zero volume recovered.

It is also noted that Google Earth image dated 11/2/17, shows visible impact on the west side of the tanks.
