Amended Administrative Order NSP-1504

Dear Mr. Schultz:

Division Administrative Order NSP-1504, dated February 2, 1987, authorized a 131.20-acre non-standard gas proration unit comprising Lots 3 and 4 and the S/2 SW/4 of Section 1, Township 6 South, Range 22 East, NMPM, West Pecos Slope Abo Gas Pool, Chaves County, New Mexico, to be dedicated to the L.L. & E. Federal Well No. 4. It was brought to our attention that this well was drilled at a location other than the one approved in the order. Inasmuch as the actual location (which is 660 feet from the South line and 1650 feet from the West line of said Section 1) is also considered a standard gas well location pursuant to the state-wide Rules, this amendment to said NSP-1504 is hereby approved.
