


Describe Cause of Problem and Remedial Action Taken.* A nipple on a water transfer pump broke, likely due to vibration and corrosion, releasing produced water into impervious lined containment. Pump was shut in and repairs were made.		
Describe Area Affected and Cleanup Action Taken.* All fluid was captured within the impervious lined containment, with no impact to the soil. Vacuum trucks were dispatched and recovered all fluids. A XTO SH&E coordinator who is competent in the operation, maintenance, and inspection of all on-site equipment and facilities visually inspected the containment and verified that there was no visual evidence of a liner breach. Containment was pressure washed and facility returned to production.
