

Gentlemen:

Conoco would like to amend the location of the above mentioned DHC Order. In an effort to prevent waste and prudently develop the Blanco Mesaverde pool, Conoco moved the drill site for the subject well 20' to the west. The new location situated the subject well at a location **1310' FSL & 10' FEL (Unit P) of Section 17, Township 28 North, Range 7 West, NMPM, Rio Arriba County, New Mexico**. This will allow Conoco to develop an additional 80-acre Mesaverde withdrawal point by recompleting (with DHC) in the existing #231E wellbore in Section 16. The #231E (API #30-039-22436) and #6 (API #30-039-07398) would then serve as the 80 acre Mesaverde pair in the southwest quarter of Section 16.

The requested location is non-standard to the interior of the San Juan 28-7 Unit, and does not encroach on any exterior Unit boundaries. An Administrative Amendment to Division Order No. R-11139 has been granted.

Conoco respectfully requests that a revised DHC be granted for the referenced well for the reasons cited above. If there are any questions concerning this application, please feel free to call me at (281) 293-1613.


