## **Application for Central Tank Battery Lease Commingle/Off Lease Sales, Storage & Measurement**

### **Oil Production & Allocation:**

The facility located at the Hackberry 26 Federal Com #2H is comprised of two separate oil batteries, one for the Hackberry 26 Federal Com #1H & another for the Hackberry 26 Federal Com #2H.

Production from each well flows into a production header and then flows through a dedicated two-phase separator, followed by a heater treater. The oil production is then routed to individual designated tanks for sales and storage. The oil production is not commingled.

### **Gas Production & Allocation:**

The gas flows from each well to a production header and then flows through a dedicated two-phase separator and heater treater. The production then flows through each well's individual scrubber before flowing to their separate allocation meter where gas production is measured for each well.

#### **Allocation Meters Numbers:**

Hackberry 26 Federal Com #1H:	309775228A
Hackberry 26 Federal Com #2H:	309775229A

Commingled gas production flows to the DCP gas sales meter 13135435. Gas production and sales will be allocated back to each well based upon the daily metered volume from the allocation meter. Sales will be allocated back to each well based upon the monthly metered volume from the allocation meter and the total sales volume from the DCP sales meter. The allocation meters and gas sales meter will be calibrated on a regulatory basis per API, NMOCD and BLM specifications.

The BLM & NMOCD will be notified of any changes to the facilities.

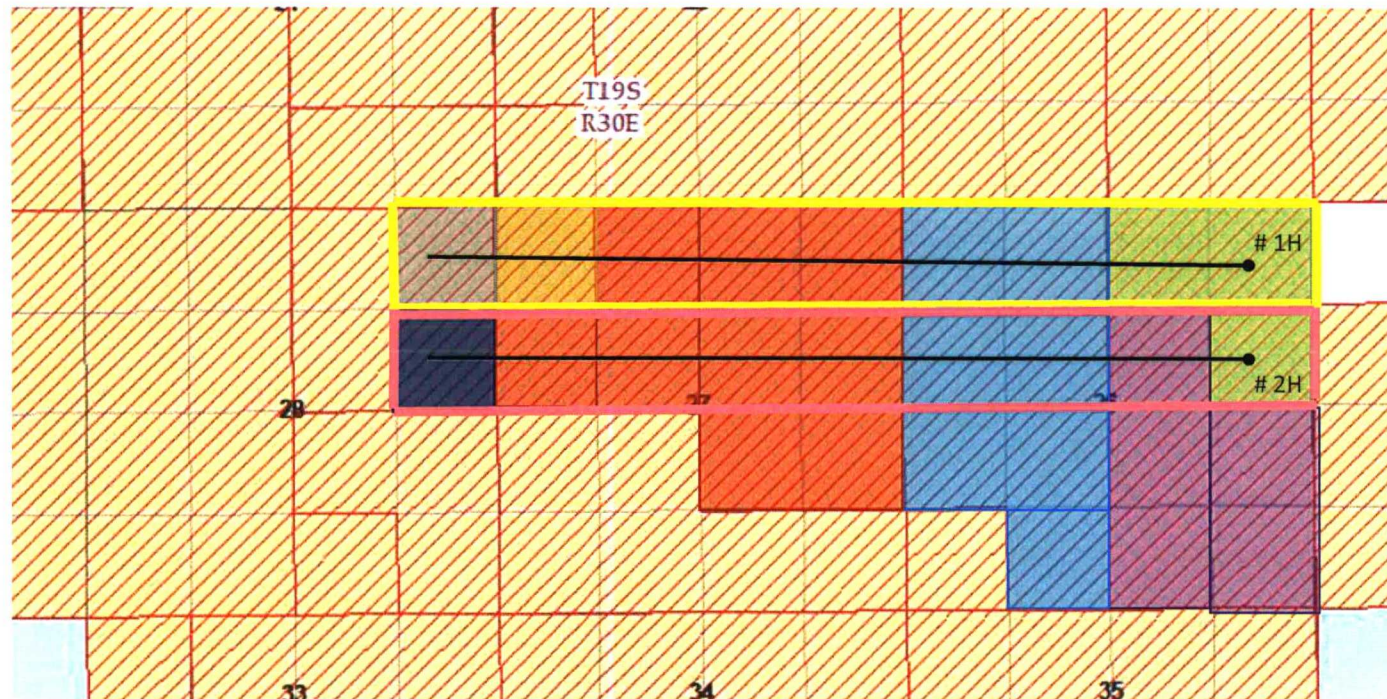

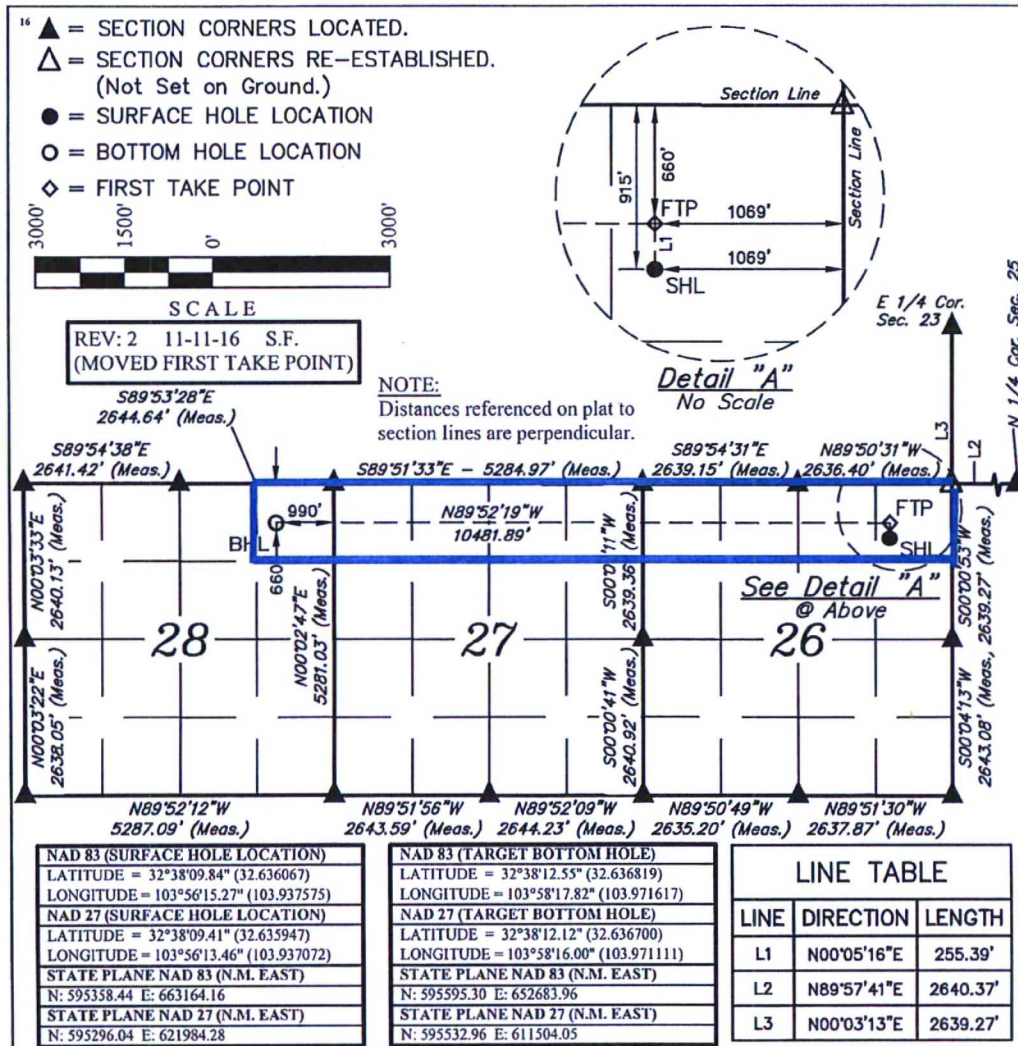

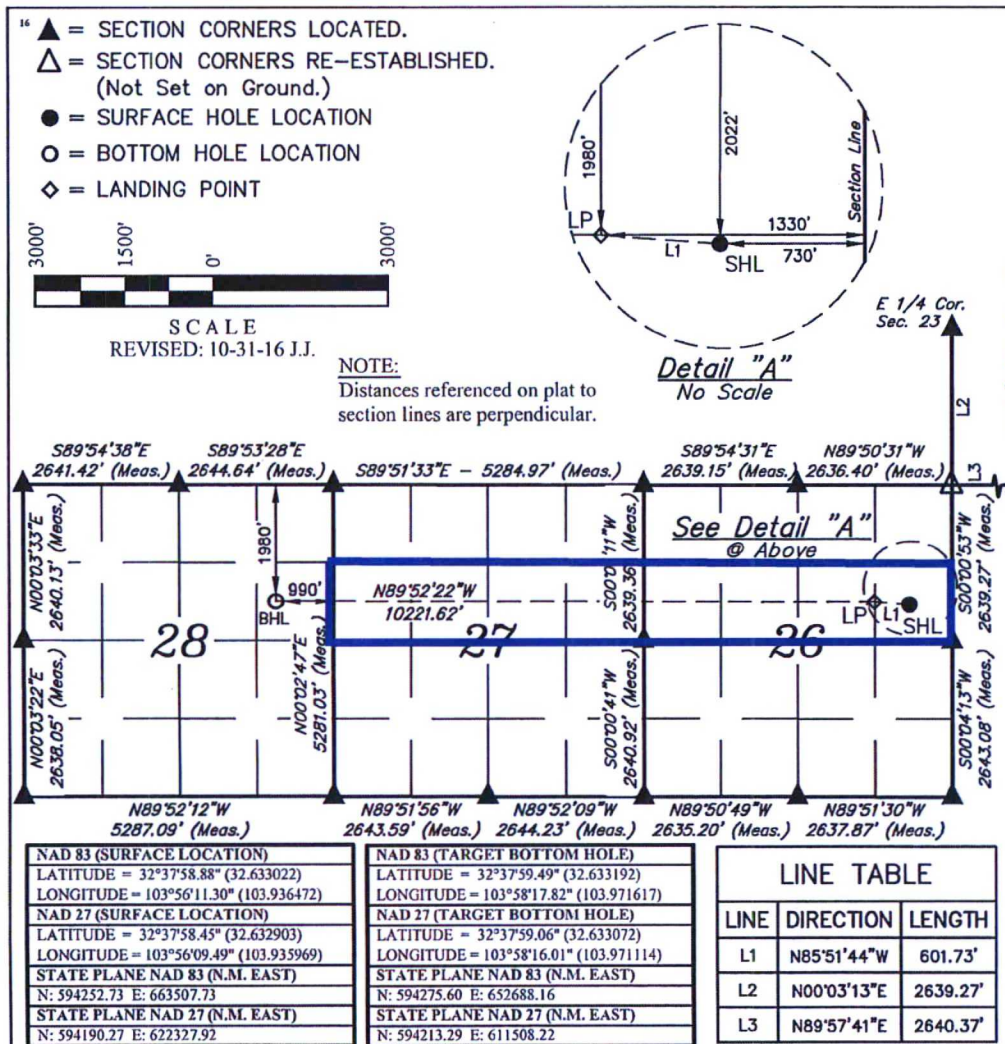

This is to advise you that Cimarex Energy Co. is filing an application with the Bureau of Land Management (BLM) and New Mexico Oil Conservation Division (NMOCD) seeking approval for a Lease Surface Commingle permit at a Central Tank Battery. Our application to the BLM and NMOCD is attached. Each well is individually metered before being commingled. The Hackberry 26 Federal Com battery is located on #2H well pad, UL/Lot H, Sec. 26, T-19S, R-30E.

In accordance with Paragraph (4)(c) of Subsection C of 19.15.12.10 NMAC prescribes that the applicant shall notify the interest owners.
