### Amended Administrative Order DD-28

Dear Ms. Perrin:

By Division Administrative Order DD-28, dated August 23, 1989, authorization was given for Nassau Resources, Inc. to directionally drill its Carracas Unit 13-A Well No. 14 from a surface location 800 feet from the South line and 1760 feet from the West line (Unit N) of Section 13, Township 32 North, Range 5 West, NMPM, Rio Arriba County, New Mexico, to a bottom-hole location in the Basin-Fruitland Coal Gas Pool within 50 feet of a target point 1700 feet from the South line and 1300 feet from the West line (Unit L) of said Section 13.

Reference is now made to your application dated January 18, 1990 to amend said Order DD-28 to reflect the actual bottomhole location for said well which is outside of the above-described target area.

The Division Director Finds That:

- (1) The application has been duly filed under the provisions of Rule 11 (d) and
  (e) of the Division General Rules and Regulations;
- (2) Satisfactory information has been provided that all offset operators have been duly notified;
- (3) The applicant has presented satisfactory evidence that all requirements prescribed in General Rule 111 will be met; and

(4) No objections have been received within the waiting period prescribed by said rule.

## **IT IS THEREFORE ORDERED THAT:**

Division Administrative Order DD-28 is hereby amended to properly show the actual bottomhole location for said Carracas Unit 13-A Well No. 14 at a measured depth of 4350 to be 1629.84 feet from the South line and 1327.13 feet from the West line (Unit K) of said Section 13 which is a standard coal gas well location for said pool.

All other provisions of said Order DD-28, dated August 23, 1989, not in conflict with this change shall remain in full force and effect until further notice.
