Administrative Order DD-22

Dear Mr. White:

Under the provisions of General Rule 111 (c), (d) and (e), Amoco Production Company made application to the New Mexico Oil Conservation Division on October 3, 1988, for authorization to directionally drill its proposed South Hobbs (GSA) Unit Well No. 223, Lea County, New Mexico.

The Division Director Finds That:

- (1) The application has been duly filed under the provisions of Rule 11 (d) and (e) of the Division General Rules and Regulations;
- (2) Satisfactory information has been provided that all offset operators have been duly notified;
- (3) The applicant has presented satisfactory evidence that all requirements prescribed in General Rule 111 will be met; and
- (4) No objections have been received within the waiting period prescribed by said rule.

IT IS THEREFORE ORDERED THAT:

(1) The applicant, Amoco Production Company, is hereby authorized to directionally drill its South Hobbs (GSA) Unit Well No. 223, the surface location of which shall be 1257 feet from the South line and 1791 feet from the West line (Unit N) of Section 34, Township 18 South, Range 38 East, Lea County, New Mexico, by kicking off from the vertical and drilling in such a

manner as to bottom in the Hobbs Grayburg San Andres Pool at a standard oil well location (as provided for in Rule 7 of Division Order No. R-4934, as amended) within the NE/4 SW/4 (Unit K) of said Section 34 forming a standard 40-acre oil spacing and proration unit for said pool.

PROVIDED HOWEVER THAT: prior to directional drilling, the operator shall determine the subsurface location of the kick-off point; and


PROVIDED FURTHER THAT: subsequent to the above-described directional drilling, should said well be a producer, a continuous multi-shot directional survey shall be made of the wellbore from total depth to kick-off point with shot points not more than 100 feet apart; the operator shall cause the surveying company to forward a copy of the survey report directly to the Santa Fe office of the Division, 310 Old Santa Fe Trail, Room 206, Santa Fe, New Mexico 87503, and the operator shall notify the Division's Hobbs District Office of the date and time said survey is to be commenced.

(2) Form C-105 shall be filed in accordance with Division Rule 1105 and the operator shall indicate thereon true vertical depth in addition to measured depths.

(3) Jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.

Amended Administrative Order DD-22(L)

Dear Mr. White:

Due to inadvertance, Division Administrative Order DD-22, dated October 25, 1988 is hereby rescinded and shall be replaced herein.

Under the provisions of General Rule 111 (c), (d) and (e), and Division Order No. R-4934, as amended, Amoco Production Company made application to the New Mexico Oil Conservation Division on October 3, 1988, for authorization to directionally drill its proposed South Hobbs (GSA) Unit Well No. 223, Lea County, New Mexico.

The Division Director Finds That:

- (1) The application has been duly filed under the provisions of Rule 11 (d) and (e) of the Division General Rules and Regulations and Rule 7 of Division Order No. R-4934, as amended;
- (2) Satisfactory information has been provided;
- (3) The applicant has presented satisfactory evidence that all requirements prescribed in General Rule 111 will be met; and
- (4) No objections have been received within the waiting period prescribed by said rule.

IT IS THEREFORE ORDERED THAT:

(1) The applicant, Amoco Production Company, is hereby authorized to directionally drill its South Hobbs (GSA) Unit Well No. 223, the surface location of which shall be 1257 feet from the South line and 1791 feet from the West line (Unit N) of Section 34, Township 18 South, Range 38 East, Lea County, New Mexico, by kicking off from the vertical and drilling in such a manner as to bottom in the Hobbs Grayburg San Andres Pool at an unorthodox oil well location 1330 feet from the South line and 1900 feet from the West line (Unit K) of said Section 34 to be dedicated to said well forming a standard 40-acre oil spacing and proration unit for said pool.

PROVIDED HOWEVER THAT: prior to directional drilling, the operator shall determine the subsurface location of the kick-off point; and


PROVIDED FURTHER THAT: subsequent to the above-described directional drilling, should said well be a producer, a continuous multi-shot directional survey shall be made of the wellbore from total depth to kick-off point with shot points not more than 100 feet apart; the operator shall cause the surveying company to forward a copy of the survey report directly to the Santa Fe office of the Division, 310 Old Santa Fe Trail, Room 206, Santa Fe, New Mexico 87503, and the operator shall notify the Division's Hobbs District Office of the date and time said survey is to be commenced.

(2) Form C-105 shall be filed in accordance with Division Rule 1105 and the operator shall indicate thereon true vertical depth in addition to measured depths.

(3) Jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.
