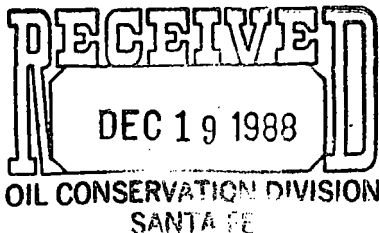

WELL Bar 4 Federal 1

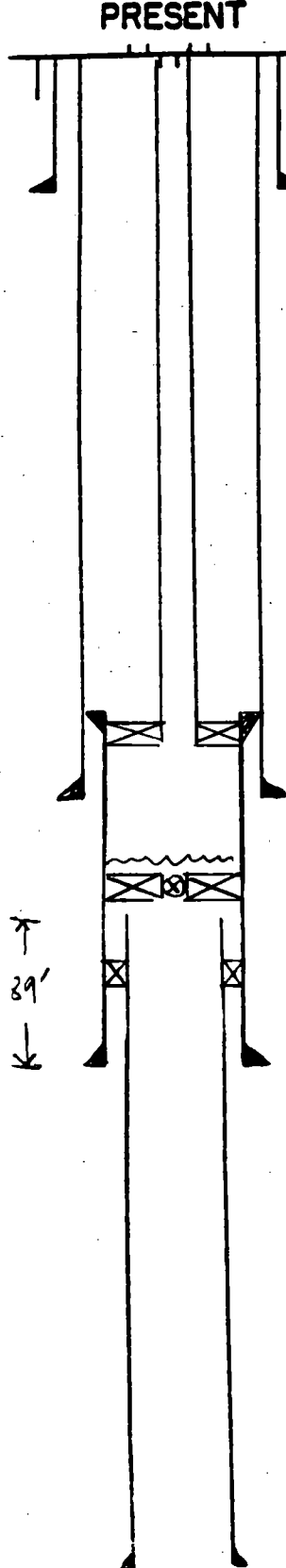

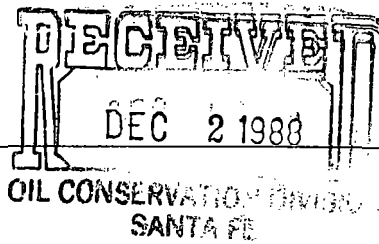
