Reference is made to your request for an exception to the tubing setting requirements as contained in Division Rule 107(d)(3).

Pursuant to the authority granted me by Rule 107(d)(4), you are hereby authorized to have a tubingless completion in the following well:

#### BDCDGU 2233-311

Unit J, Section 31, Township 22 North, Range 33 East, NMPM, Union County, New Mexico.

REMARKS: Due to the fact that the Yeso and Cimarron formations are exposed in this wellbore, Amoco Production Company shall be required to continuously monitor the performance of this well. In the event that the integrity of the open-hole section of this wellbore becomes questionable, the operator will be required to perform remedial work within thirty days to ensure that no vertical migration of carbon dioxide occurs. Should the well be shut-in for any reason, Amoco Production Company shall advise the Division's District IV office immediately. It is also required that the operator file quarterly reports on this well's performance for the District IV office in order to ascertain that waste is not occurring.

The Division reserves the right to rescind this authority in the event that waste appears to be resulting therefrom.

Amoco Production Company requests an exception to Rule 107 (J), in order to drill and complete Bravo Dome Carbon Dioxide Gas Unit Well Number 2233-311J.

Amoco has run 4 1/2 inch production fiberglass casing and will produce the well through the casing in lieu of producing through the tubing. In support of our request, the following reasons exist.

- 1. Eliminate casing corrosion.
- 2. Eliminate expense for tubing, on and off tool, packer and inhibited fluid.
- 3. Increase production rates since well can flow up the casing.
- 4. The well is not a wildcat or dual completion, and will be completed with a total depth of less than 5000 feet.

A well bore schematic is attached for your information and review.
