

Energen Resources Corporation (Energen) hereby requests Administrative Approval for an Unorthodox Location of its Jicarilla 98 # 2C Mesaverde well under the Provisions of New Mexico Oil Conservation Division (NMOCD) order R-10987-A.

This well is located 1800' FNL & 2120' FEL of Section 19-T26N-R3W, Rio Arriba County, New Mexico and dedicated to a spacing unit consisting of the E/2 of Section 19, in the Blanco Mesaverde gas pool.

This well is closer then 660' to the Western Boundary of the prorating unit due to the fact that a standard location would be in the middle of the wash and in order to cross the wash to the east, it would be too close to the existing Jicarilla 98 # 2, a Mesaverde completion.

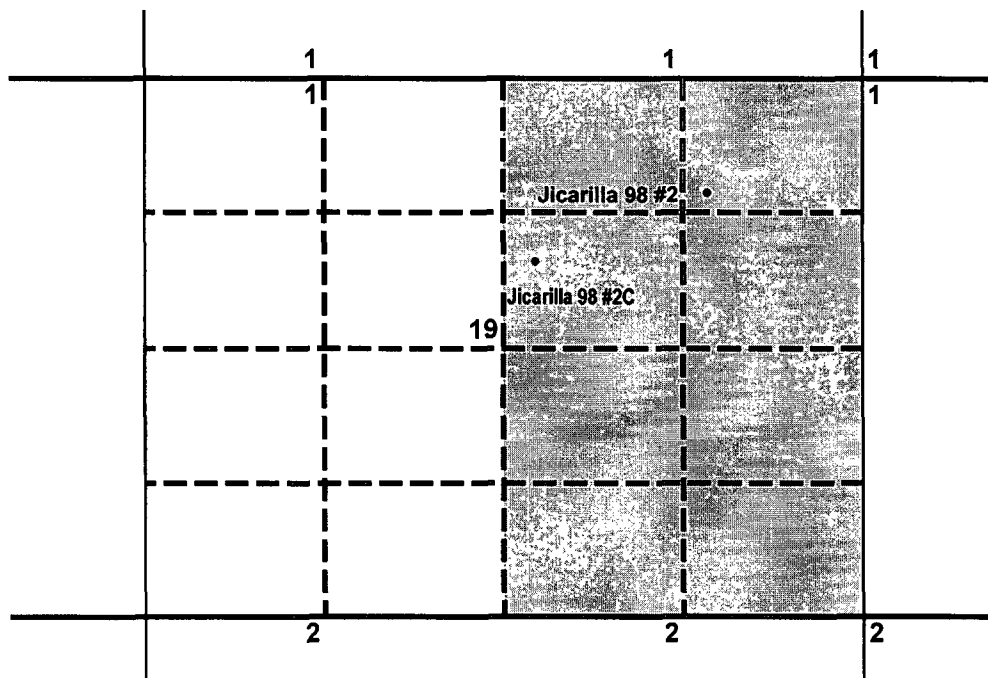

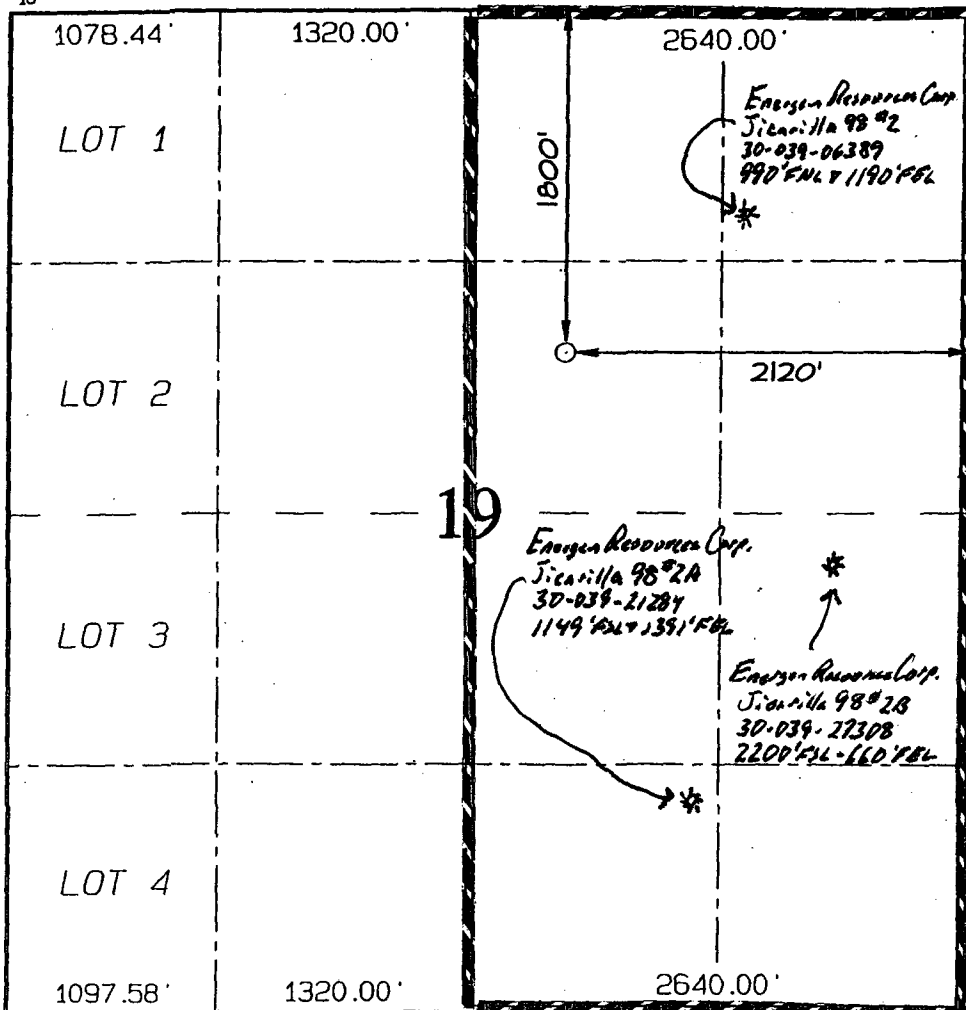

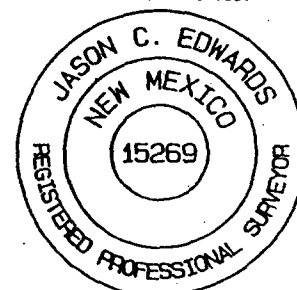
