## *COMMINGLING ORDER PLC-280*

The above-named company is hereby authorized to surface commingle gas production from the Mosley Canyon-Strawn (Gas – 81470) and Baldrige Canyon-Morrow (Gas – 71420) Pools originating from the following-described area that encompasses all or parts of State of New Mexico Leases No. LG-5172, LG-4320, LG-5173 and L-4500.

### Township 24 South, Range 24 East, NMPM:

Section 1: E/2  
Section 11: All  
Section 12: W/2  
Section 13: W/2

Within this area, Mewbourne Oil Company currently operates the Outlaw Flats "1" State Well No. 1 (API No. 30-015-32220) located in Unit O of Section 1, which currently produces from the Baldrige Canyon-Morrow Pool, the Baldrige Canyon "11" State Well No. 1 (API No. 30-015-30038) located in Unit L of Section 11, which currently produces from the Baldrige Canyon-Morrow Pool, the Baldrige Canyon "11" State Com Well No. 2 (API No. 30-015-30462) located in Unit G of Section 11, which currently produces from the Baldrige Canyon-Morrow Pool, the Baldrige Canyon "12" State Com Well No. 2 (API No. 30-015-30416) located in Unit C of Section 12 which currently produces from the Baldrige Canyon-Morrow Pool and the Stetson Creek "13" State Com Well No. 1 (API No. 30-015-32121) located in Unit C of Section 13, which currently produces from the Mosley Canyon-Strawn Pool.

Due to the diversity of ownership between the wells, gas production shall be separately metered by allocation meters prior to commingling. After being measured, the gas will be combined and sent on to a gas sales meter located in Section 11, Township 24 South, Range 24 East, NMPM, on the Baldrige Canyon "11" State Lease. No liquids shall be commingled.

It is the responsibility of the producer to notify the transporter of this commingling authority. The operator shall notify the Artesia District Office of the Division upon commencement of commingling operations.


