Transfer pump went down due to electrical storm from previous night allowing tank to fill up to 10' where a hole developed allowing fluid to be released. Reset transfer pump and equalized from bottom into empty tank. Tank removed from service.

Describe Area Affected and Cleanup Action Taken.* All fluid was contained within a lined berm. Oil was skimmed off with vacuum truck and put in stock tank and remaining water vacuumed up.
