## **CORRECTED Division Administrative Order SD-06-17**

Dear Mr. Allred:

Due to inadvertence Division Administrative Order SD-06-17 issued on Division administrative application reference No. pTDS0-616738636 and dated June 16, 2006 does not correctly state the intended of the Division.

The third paragraph on page 1 of Division Administrative Order SD-06-17, be and the same, is hereby amended to read in its entirety as follows:

*"By Division Order No. R-916, issued in Case No. 1157 and dated November 13, 1956, this 360-acre non-standard gas spacing unit was initially established for Plantation's Meyer B-28 "A" A/C-2 Well No. 2 (API No. 30-025-06273), located at a standard gas well location 660 feet from the South line and 1980 feet from the East line (Unit O) of Section 28."*

Furthermore, the forth paragraph on the bottom of page 1 of said Order SD-06-17, be and the same, is hereby amended to read in its entirety as follows

*"By Division Order No. R-4977, issued in Case No. 5414 and dated March 11, 1975, the Division allowed the simultaneous dedication of this 360-acre unit to the above-described Meyer B-28 "A" A/C-2 Well No. 2 and the Meyer B-28 "A" A/C-2 Well No. 3 (API No. 30-025-24877), located at a location now considered to be standard but unorthodox at the time it was drilled in late 1974, 760 feet from the North line and 1880 feet from the West line (Unit C) of Section 33. This well was subsequently plugged and abandoned in September, 2005."*
