**Administrative Order NSL-5411**

Dear Mr. Corcoran:

Reference is made to the following: (i) your application dated May 31, 2006 that was submitted to the New Mexico Oil Conservation Division ("Division") in Santa Fe, New Mexico on June 5, 2006 (*administrative application reference No. pTDS0-615654421*); and (ii) the Division's records in Aztec and Santa Fe: all concerning CDX Rio, L.L.C.'s ("CDX") request for an exception to the well location requirements provided within the "*Special Rules and Regulations for the Basin-Dakota Pool*," as promulgated by Division Order No. R-10987-B, dated June 30, 2000, as amended by Division Orders No. R-10987-B (1), dated August 10, 2000, and R-10987-B (2), dated January 29, 2002, for its proposed Jicarilla Apache Tribal "151" Well No. 1-F to be drilled at an unorthodox infill gas well location 2155 feet from the South line and 2490 feet from the East line (Unit J) of Section 10, Township 26 North, Range 5 West, NMPM, Basin-Dakota Pool (**71599**), Rio Arriba County, New Mexico.

The Basin-Dakota gas production from this well is to be included within an existing standard 320-acre lay-down gas spacing and proration unit ("GPU") comprising the S/2 of Section 10, which is currently dedicated to CDX's: (i) Jicarilla Apache Tribal "151" Well No. 1 (**API No. 30-039-08166**), located at a standard gas well location 1180 feet from the South line and 1480 feet from the West line (Unit N) of Section 10; and (ii) Jicarilla Apache Tribal "151" Well No. 1-E (**API No. 30-039-23171**), located at a standard infill gas well location 830 feet from the South line and 1120 feet from the East line (Unit P) of Section 10.

This application has been duly filed under the provisions of Division Rules 104.F and 605.B and the applicable rules governing the Basin-Dakota Pool.



By the authority granted me under the provisions of Division Rule 104.F (2), the above-described unorthodox Basin-Dakota infill gas well location for CDX's proposed Jicarilla Apache Tribal "151" Well No. 1-F is hereby approved. Further, all three of the aforementioned Jicarilla Apache Tribal "151" Wells No. 1, 1-E, and 1-F and existing 320-acre GPU will be subject to all existing rules, regulations, policies, and procedures applicable to prorated gas pools in Northwest, New Mexico and to the Basin-Dakota Pool.
