Mack Energy contract operator for COG Operating LLC respectfully requests an administrative approval without notice and hearing of the following unorthodox well location.

Because of our desire to drill this well in a timely manner, we also request your approval be expedited. The well location and legal description is as follows:

The well will be completed in the Grayburg/San Andres formation in the Grayburg Jackson SR Q G SA Pool.

Moving the location 77' to the west will give the distance needed to build a location away from the gas pipeline. The location would have to be moved approximately 300' east to get away from the pipeline to make it orthodox. There are no other possible orthodox locations for this well due to one producing well and two other staked wells being located on 10-acre spacing. The acreage that we are encroaching on is also owned by COG Operating LLC.






