RE: Application to grant R. B. Honeyman, Jr. - Wulff State #2 - exception for an unorthodox location, occasioned by recompletion of an oil well.

By this letter of application R. B. Honeyman, Jr. wishes to state the following:

- (a) That R. B. Honeyman, Jr. - Wulff State #2, located 2310' from the North line and 990' from the West line of Sec. 17, T. 20S, R. 37E., was originally completed as an oil well in the Monument Pool on April 12, 1937.
- (b) That subject well has an oil string of 7" casing set @ 3747' cemented with 400 sax. The original T.D. was 3860'. Subsequent plug-back operations in conjunction with packer tests as evidenced on Form C-103's as filed with the Commission have failed due to water encroachment to successfully re-complete as an economic oil producer.
- (c) That subject well is now successfully plugged-back and perforated in the Eumont Gas Zone from 3347-3397', 3440-3468', and 3507-3517'.
- (d) That the granting of this application is in the interest of conservation and protection of correlative rights.
- (e) By this written stipulation the undersigned has submitted a copy of this application and a plat to all operators within a 1320' radius as herein listed.

Therefore, R. B. Honeyman, Jr. requests that the Oil Conservation Commission grant permission to the applicant as outlined in Rule 4, Order # 370 A, Eumont Gas Pool, for an unorthodox location of a gas well.





See Well Plat


