<u>AMENDED</u> AGREED COMPLIANCE ORDER

Pursuant to Ordering Paragraph 3 of Agreed Compliance Order 118 (hereinafter "Order"), between BEPCO, LP (formerly Bass Enterprises Production Co.) and the Oil Conservation Division ("OCD"), the Director of the OCD hereby amends that Order as follows:

FINDINGS

1. The Order requires BEPCO, LP, formerly Bass Enterprises Production Co. ("Operator") to return to compliance with OCD Rule 201 at least 4 of the wells identified in the Order by September 20, 2006, and file a compliance report by that date.

2. The Order further provides that if Operator returns to compliance with OCD Rule 201 at least 4 of the wells identified in the Order by September 20, 2006, and files a timely compliance report, the OCD shall issue an amendment extending the terms of the Order for an additional six-month period, requiring Operator to return to compliance by March 20, 2007 at least 4 additional wells identified in the Order.

3. Operator filed a timely compliance report, and the OCD has verified that OCD records indicate that Operator has returned to compliance the following wells identified in the Order:

1. Bass 10 Federal #005	30-015-25303
2. Big Eddy Unit #038	30-015-20940
3. Big Eddy Unit #094	30-015-24084
4. Poker Lake Unit #043	30-015-21700

CONCLUSIONS

1. Operator has met its goal of returning 4 of the wells identified in the Order to compliance by September 10, 2006.

The OCD should amend the Order to extend its terms through March 20, 2. 2007 and require Operator to return to compliance by that date 4 wells identified in the Order that are not identified in Findings Paragraph 3, above.

ORDER

Operator shall return to compliance by March 20, 2007 4 wells identified 1. in the Order that are not identified in Findings Paragraph 3, above.

Operator shall file a compliance report by March 20, 2007 using the Oil 2. Conservation Division's web-based on-line application.

3. The terms of Agreed Compliance Order 118 otherwise remain in effect and are extended through March 20, 2007.
