External corrosion of a 6" steel discharge line caused the release. Line was clamped to mitigate the release and will be replaced. Station has a daily throughput of 60 barrels. The pressure on the line is <50 lbs and the gravity is 37.6. Depth of the line at the release location is 6" bgs.

Affected soils will be remediated per applicable NMOCD regulatory standards.
