Attached hereto is a letter from Mr. O. R. Hedges of Los Angeles, California, giving me authority to act as his agent in New Mexico.

We employed Mr. Cartwright of Cimarron, New Mexico, a liscensed Surveyor, to run elevations to determine the highest point on a ridge running north-east and southwest, where we propose to drill a test well for oil and/or gas.

The highest point on this ridge is 2739.8 ^{East} feet North of the South line, and 338.3 feet ~~West~~ of the ~~East~~ ^{West} line of Section 18, Township 25 N, Range 20 E, and constitutes an unorthodox location.

We respectfully request that we be granted special permission to drill on this location as it is advantageous because of topographical consitions, all oil and gas leases within 660 feet of the location are owned by Orris R. Hedges, Los Angeles, California, and a letter of consent from McDaniel Investment Company is attached, as Rule 104, Section (f) of New Mexico Oil Conservation Commission Rules and Regulations sets out.


