This is to request administrative approval of an unorthodox location to be located in the Aztec Pictured Cliffs Extension Pool.

The well, our Johnston No. 2, is located 1800' from the South line and 870' from the East line of Section 9, Township 28 North, Range 9 West, N.M.P.M., San Juan County, New Mexico. The portion of the section in which the well is located consists of high sandstone bluffs and a dry wash. In order to have the location accessible it was necessary to put the location on top of one of these bluffs.

The well is to be a Pictured Cliffs completion. El Paso Natural Gas Company holds the lease in the W/2 of E/2 of Section 9, Township 28 North, Range 9 West. The SE/4 of Section 33, Township 29 North, Range 9 West is held by Delhi-Taylor Oil Corporation and the enclosed letter gives their approval of the unorthodox location. Approval was sought from Stanolind Oil and Gas Company since our records indicated that they were the operator of the SW/4 of Section 33, Township 29 North, Range 9 West. We were advised by Stanolind Oil and Gas that the operation had been quitclaimed to David J. Simmons, as is stated in the enclosed letter. Mr. Simmons has been notified by registered mail and his approval of the unorthodox location requested, but as of this date we have not received Mr. Simmon's approval. We will forward the approval to you as soon as it is received.

I am enclosing two copies of the Certified Well Location Plat sketching terrain conditions and two copies of our Intention to Drill.


