This is a request for Administrative Approval of an Unorthodox Location. in the Horseshoe Canyon Gallup Pool. This location, our Horseshoe Canyon No. 7, is located 1673' from the South Line and 1628' from the West Line of Section 3, Township 30-N, Range 16-W, NMPM, San Juan County, New Mexico. The NE SW of Section 3 is dedicated to this well. This well is to be drilled through the Gallup Formation and then all possible producing zones will be perforated and sandoil fractured. This location is on a rock / ledge on the steep slope of the side of a canyon. It would be extremely hard and expensive to make an Orthodox Location and your approval of this 1 Alshie request would be greatly appreciated.

Mr. Tom Bolack owns the lease in the NW SW of Section 3 and he has been notified by Registered Letter of our intention to build this Unorthodox Location.



Well Location and Acreage Dedication Plat


