Gentlemen:

As required in the Special Rules and Regulations for the Kemnitz-Wolfcamp Pool, Order No. R-1011, Phillips Petroleum Company requests from the Secretary of the Commission exception to the requirements of Rule 3 (a).

Forms C-101, Notice of Intention to Drill, and C-128, Well Location and Acreage Dedication Plat, are being filed this date with the Commission's District I office, showing the subject well's location as 1983' from South and 2313' from West line of Section 25, T-16-S, R-33-E, Lea County.

This unorthodox location is requested for reason that the regular location in the center of the NE/4 of the SW/4, which measured 1983' from the South and 1983' from the West lines of Section 25, is a large dry lake. There is no increase in elevation within a 150' radius from the center of this quarter quarter section. An increase in elevation of 6" was found at 200' from the center. An increase in elevation of 3'6" was found at 330' from the center, which is the minimum distance required for protection from surface flooding. Therefore, in order to locate this well above the high water mark and to avoid excessive location costs, it is our desire to drill this well in the unorthodox location.

By copy of this application we are giving notice to Tennessee Gas Transmission Company, the only operator within a 1320' radius of the subject well, of this proposed unorthodox location.
