Dear Mr. Porter:

As Operator of the Northeast Blanco Unit, we request permission to drill an unorthodox well, to be located 2230' from the North line and 1800' from the East line of Section 19, T 31 N, R 7 W, San Juan County, New Mexico. We want to drill Well No. 66-19 on this location.

Because of the extremely rough terrain in and surrounding the normal location for this well, it is necessary to select a more suitable drilling site.

Section 19-31N-7W is a part of the Northeast Blanco Unit and all leases within a 790' radius of the unorthodox location, as requested, is jointly controlled by the Northeast Blanco Unit participants.

We enclose a location plat of the requested location.

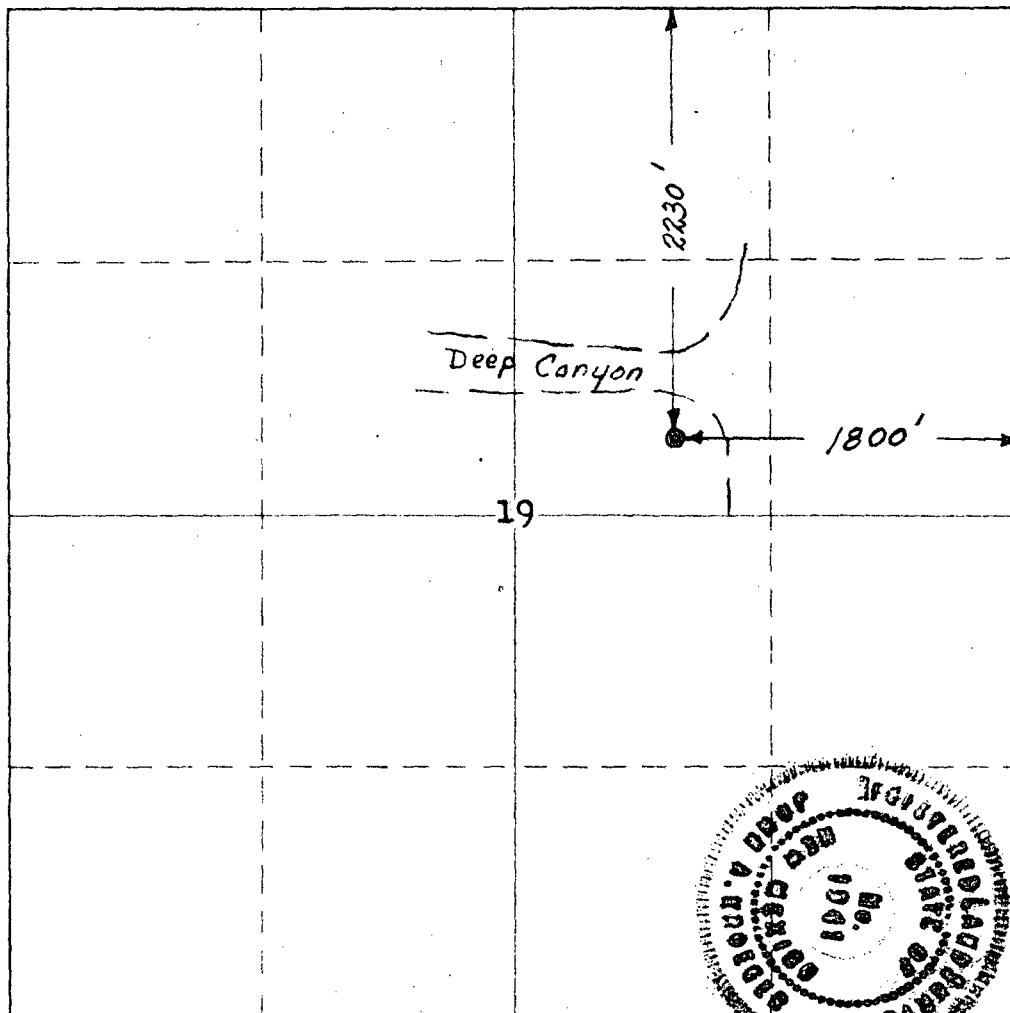
