Gentlemen:

Please refer to your letter of August 22, 1958 and to Neville G. Penrose, Inc. application for a 160-acre non-standard gas proration unit for subject well in the Eumont Gas Pool dated August 18, 1958. Neville G. Penrose, Inc. makes this application for approval of an exception to Rule 2 of Order No. R-520 to provide an unorthodox location for the Mattern #7 well.

In this connection, Neville G. Penrose, Inc. wishes to state the following facts:

- (1) Neville G. Penrose, Inc. Mattern #7 well is located 1650' from the west line and 330' from the south line of Section 7, T-22-S, R-37-E, Lea County, New Mexico. Subject well was completed in the Arrowhead Pool on February 18, 1940 and conformed to the requirements for a standard location in effect at that time. This was prior to the adoption of Order R-520. The well was recompleted in Eumont Gas Pool on August 14, 1958.
- (2) All operators within a 1980' radius of subject well as listed below, have been notified by registered mail of this application by copy thereof this date.
- (3) Neville G. Penrose, Inc. is operator of all acreage comprising the proposed unit on which subject well is located.

Neville G. Penrose, Inc. respectfully requests that an administrative exception be granted to said Rule 2 of Order no. R-520 and that subject well be approved for the

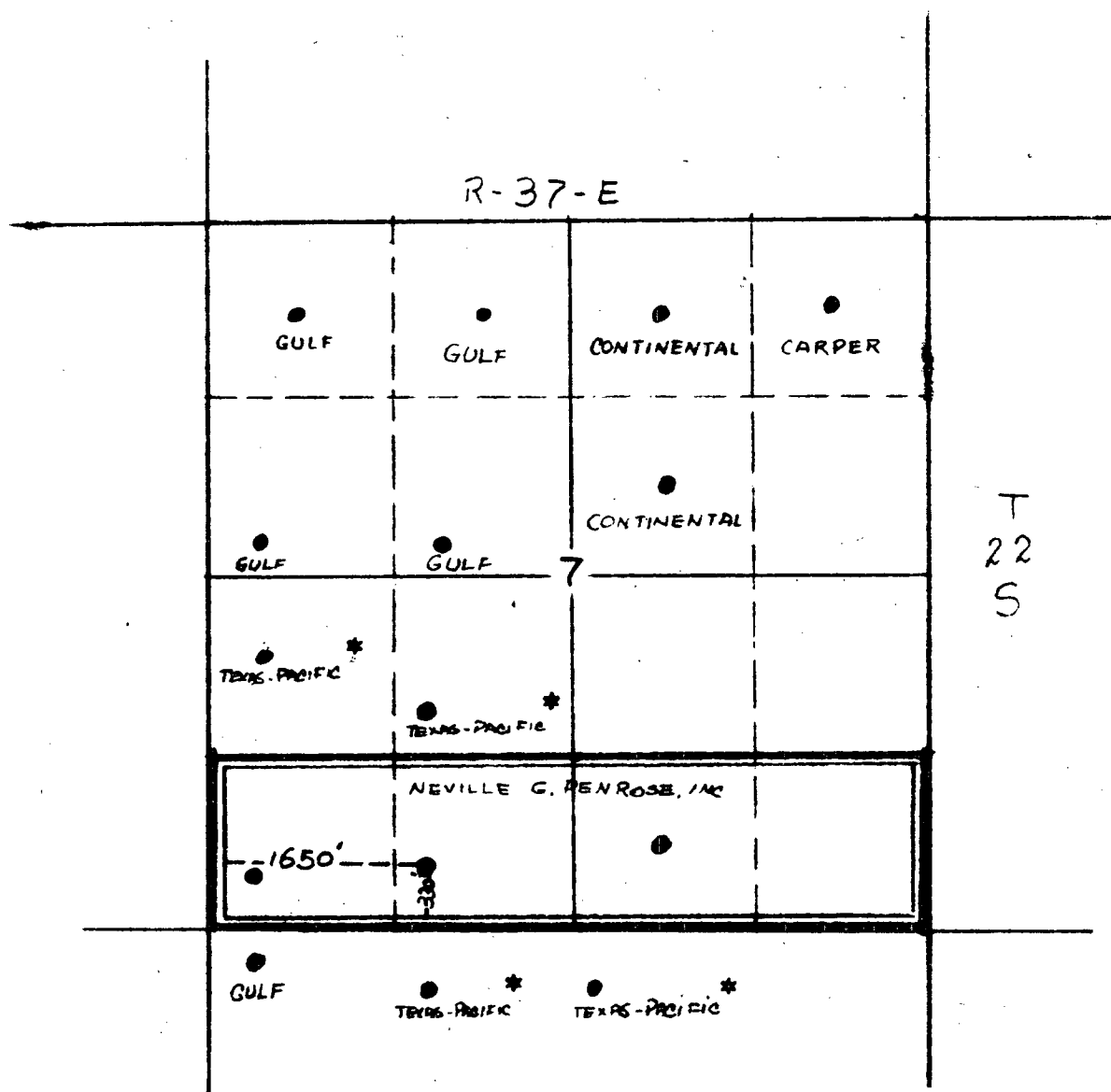
