Gentlemen:

Sinclair Oil & Gas Company hereby makes application for administrative approval under Order R-586 for an unorthodox well location and for an 80-acre nonstandard proration unit in the Tubb Gas Pool, Lea County, New Mexico. The Unit will consist of Sinclair's R. L. Brunson lease which occupies the 1/2 of the SE/4 of Section 4-22S-37E and will be assigned to Sinclair's R. L. Brunson Well #1. This well is located 330 feet from the North and West lines of the SE/4 of said Section 4. Said 80-acre nonstandard proration unit is colored in yellow and said Well #1 is circled in red on the attached ownership map.


The unorthodox location is occasioned by the dual completion of Sinclair's R. L. Brunson Well #1 which was previously drilled and completed in the Drinkard Pool on August 16, 1947, which was prior to the date of the special Tubb Gas Pool rules and therefore, qualifies for an administrative exception to Rule 2 of Order R-586.

Sinclair's R. L. Brunson Well #1 is the only well on this lease which is completed in the Tubb Gas Pool. We believe that the proposed 80-acre nonstandard proration unit complies with all of the requirements listed in Rule 5 (d) of Order R-586. The leasehold and Royalty Interests are common under the proposed Unit.

All offset operators and all operators within a 1980 foot radius of subject well have been furnished a copy of this application via registered mail this date. Please advise if we can furnish any additional information concerning this matter.


