In accordance with the provisions of NMOCC's Rule No. 104(f) delegating the Secretary of the Commission authority to approve an unorthodox well location by administrative action without notice and hearing, Pan American Petroleum Corporation hereby applies for your approval of an unorthodox location for the South Mattix Unit Well No. 11 by the granting of an exception to the location requirements of Rule 104(d). /

In support of the application, the following data is furnished:

(1) Application is submitted in triplicate.
