Pursuant to Rule 2(b) of Order R-1670-C, Aztec Oil & Gas Company hereby submits, in triplicate, its application for administrative approval of an exception to the well location regulation set forth in Order R-1670-C and requests administrative approval of an unorthodox drilling location in the Southeast Quarter (SE $\frac{1}{4}$ ) of Section 18, T-29-N, R-13-W, N.M.P.M., San Juan County, New Mexico.

In support of this application, Applicant respectfully states and shows the following:

1. The proposed unorthodox drilling location has been staked six hundred and sixty feet (660') from the east line and one thousand nine hundred and eighty feet (1980') from the south line of Section 18. This unorthodox location is necessitated by topographical conditions, and Tenneco Oil Company, Texaco, Inc., and Sunray Mid-continent Oil Company, the only operators offsetting leases or leases within the section, as indicated on Exhibit "A" attached hereto and made a part hereof, has been furnished a copy of this application by registered mail along with a request that they waive notice and hearing.

2. Applicant intends to drill a well on the unorthodox drilling location, if approved, to be known as the Harris #1-D and to complete it as a gas well producing in the Basin Dakota Pool.



Dear Mr. Porter:

On June 16, 1961, Aztec Oil & Gas Company filed its Application for Administrative Approval of an unorthodox drilling location six hundred and sixty feet (660') from the east line and one thousand nine hundred and eighty feet (1980') from the south line of Section 18, T-29-N, R-13-W, N.M.P.M., San Juan County, New Mexico, for its Harris #1-D well.

As grounds for the approval of the unorthodox drilling location, Applicant cited topographical conditions.

It has been determined that such grounds are not supported by the facts, and Applicant respectfully requests that such Application be amended accordingly.

Applicant has previously incurred considerable expense in constructing a location, as described above, for the drilling of a Gallup well. Recent drilling in the area has indicated that the Gallup formation may not be productive at this location, and Applicant wishes to utilize such location for the drilling of the Harris #1-D well, planned as a test well in the Basin Dakota Gas Pool.
