Dear Sir:

The Pure Oil Company is planning to drill our Federal "H" #1, located 1060.29 feet from the North line, and 2296.91 feet from the East line of Section 24, T28S, R2W, NMPM, Dona Ana County. This location is unorthodox in that it is 259.71' from the boundary line of the quarter-quarter section in which it is located.

The proposed wildcat well is in the East Potrillo Mountains, and the topographical conditions are such that it is not practical to locate the well in any other manner and still test the desired formations. This well is a rank wildcat, and there are no oil or gas wells within miles of the proposed location.

The Pure Oil Company is the owner of this lease and all leases within a radius of 660' of the proposed location.

Therefore, The Pure Oil Company respectfully requests that the proposed location be approved as an exception to Rule 104 (Well Spacing). A certified well location plat is enclosed.


