Although this proposed drilling location is situated only 530 feet from the North boundary line of Tract B, as delineated in your Order No. R-2086, all other acreage lying within that tract is of such rough and uneven terrain that road and location costs are prohibitive. Too, this location lying 790' from the South line and 790' from the West line of Section 6 conforms with the NE/4 - SW/4 drill site pattern prevailing in the area and we are the lease owner of all of Section 6.

Considering the topography and drilling pattern in this area, we respectfully request approval of this location.

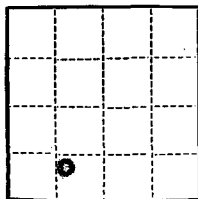

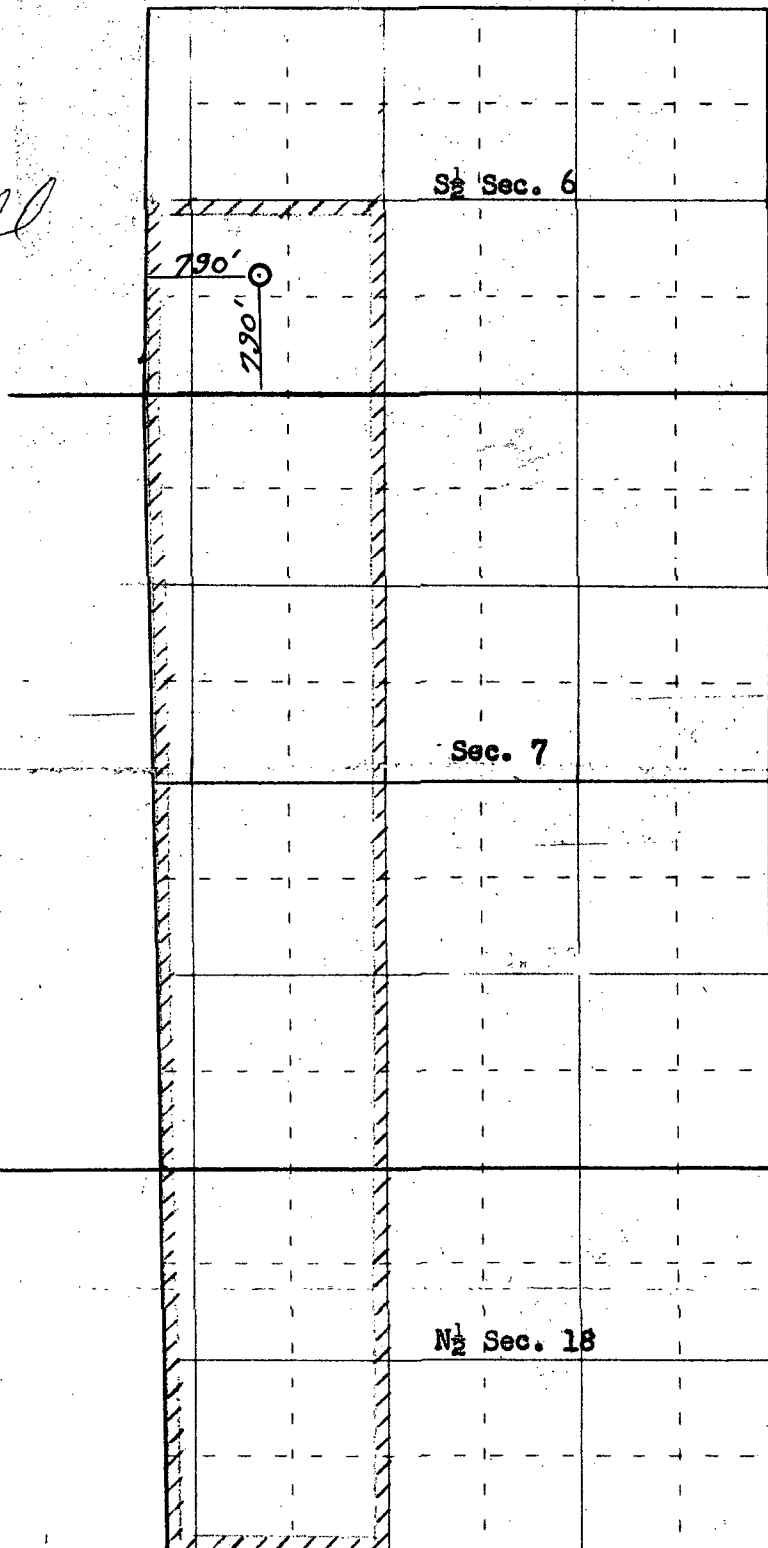
