



DETAILS OF WORK

Plan to set 30' of 7", 20#, J-55 surface casing, cement to surface. Drill 6 1/2" hole to the top of the Lower Gallup w/air. Cut 20' core w/air and/or oil, run 4 1/2", 9.5#, J-55 casing, cement w/sufficient amount to cover approximately 250' above producing zone. Well to be perforated w/jet-notch gun and sand-fraced w/40,000# of sand and approximately 1000 bbls of oil. Estimated tops of formations are as follows:

Lower Gallup - 1623'  
T.D. - 1675'
