Request for Administrative Approval, Unorthodox Location (Dakota), Consolidated Oil & Gas, Inc., Navajo No. 3-11 Well, Section 11, T25N, R 10 W, NMPM, San Juan County, New Mexico

This is to request administrative approval for the above referenced unorthodox Dakota location under Rule 3 of paragraph A, Order No. R-1670 of Section II of the Rules and Regulations, Oil Conservation Commission of the State of New Mexico.

Consolidated is requesting a location 710 feet from the east line and 1850 feet from the south line. It is necessary that the location be moved east so as to avoid interference with Highway 44, the Southern Union Gas Company's pipelines and telephone lines in the area.

We have included a plat showing a portion of San Juan County, New Mexico with offset operators, existing wells and zones of completion. Also attached is a copy of the Well Location and Acreage Dedication Plat (Form C-128).

In order to expedite approval of this application, we have requested offset operators' approval in advance of submitting this request. Letters expressing no objection from El Paso Natural Gas Company and Mrs. Eugene H.






