
Dear Mr. Porter:

AAA Fishing Tool Co. Inc. is requesting administrative approval to drill an unorthodox location located 1450' fcl and 2510' fsl, Sec. 15, T 32 N, R 18 W, San Juan County, New Mexico. The location of the well is 130' from the north line and 130' from the east line of the proration unit boundary.


