L. R. French, Jr., and Jack N. Blair drilled a Devonian test 660 FNL & 1650 FWL of Section 28, T-18-S, R-33-E, Lea County, New Mexico. The well tested water in the Devonian, however, the well was completed as a Morrow gas well.

Since this well is a non-standard location, we are requesting a non-standard 240 acre gas unit which includes the NE/4 and the E/2 of the NW/4 of Section 28, T-18-S, R-33-E. On March 4th, we wrote a letter to Mobil Oil Company informing them that they either give us letters of waiver or join us on a 320 acre unit. We have contacted them several times and have received no answer. Therefore, we assume that Mobil is uninterested in joining in this gas unit. A copy of the letter to Mobil is enclosed. Also attached is a plat of the area showing all offset operators.

We have made a gas contract with with Southern Union, we have all of our equipment in place, and the well is ready to deliver gas. We want to sell the gas and Southern Union wants to buy it. Therefore, will you please give us an allowable for a non-standard unit in a non-standard location.

Dear Sir:

L. R. French, Jr. and Jack N. Blair drilled a Devonian test 660 FNL and 1650 FWL of Section 28, T-18-S, R-33-E, Lea County, New Mexico. The well tested water in the Devonian, however, the well was completed as a Morrow gas well.

We held an option on the W/2 of the NW/4 from Mobil Oil Company, however, this option has expired. On completion of this well, Aztec joined French and Blair in the completion of this well in the Morrow. We hope to make a non-standard 240 acre gas unit which includes the NE/4 and the E/2 of the NW/4. Therefore, we are requesting that Mobil give us a letter of waiver for the non-standard location and the non-standard unit.

We realize that Mobil has the option to pool their W/2 of the NW/4 to make a 320 acre gas unit and would join us on an adjusted basis for the Morrow well. Southen Union will be the gas purchaser, and a line has been laid to them. To speed up and facilitate in putting this well on production, we request an answer as to whether Mobil wishes to pool or give us the waiver letters. Please let us know as soon as possible.

We do not intend to drill on Mobil's acreage and we are returning at Mobile's request, the original farmout letter which is attached.
