This is a request for administrative approval for an unorthodox gas well location in the South Blanco Pictured Cliffs Pool.


It is intended to locate the well, El Paso Natural Gas Company Florance D No. 16, 2357 feet from the North line and 800 feet from the East line of Section 20, Township 27 North, Range 8 West, N.M.P.M., San Juan County, New Mexico. The NE/4 of Section 20 is dedicated to this well.

As shown on the enclosed plat, the NE/4 of Section 20 consists of steep rock cliffs. The only accessible land for a well in the NE/4 is that which makes the location unorthodox. It is, therefore planned to make the location unorthodox in order that the extremely high cost of constructing an orthodox location be avoided.

Since El Paso Natural Gas Company holds all leases within the 790' radius the consent of any other operators to said location is not necessary.

I am enclosing two copies of the certified well location plat, and two copies of the notice of intention to drill.


