Dear Mr. Sherrell

I have received copies of the notices you sent of these administrative applications to Cimarex Energy Co., Devon Energy Corporation and Marbob Energy Corporation.

The Division records, if I am reading them correctly, show the following as offset operators:

east, southeast and south of both units - COG
west of both units - Cimarex
northeast of the Lot 3 Clayton Williams

I find no producing wells shown in the Empire Yeso north or northwest of Lot 3, or southwest of Lot 4.

I assume Cimarex was noticed because of their offsetting wells to the west.

Why were Devon and Marbob noticed? Are they working interest owners in offsetting units operated by COG? If so, are they all of the working interest owners in offsetting units operated by COG where working interest ownership is not identical to that in Lots 3 and 4?

Why was Clayton Williams not notified? I realize that it is possible that Unit F of Section 19 does not actually touch Lot 3, but it would appear to do so from the C-102 furnished. If it does touch at a point, then it is an "adjoining spacing unit." See Rule 7.A(3).

What about the working interest owners in Lot 2 and in the units to the northwest of Lot 3 and to the southwest of Lot 4, where there are apparently no producing Yeso wells? Working interest owners in these units would need to be noticed unless COG owns the entire working interest in these units, or the working interest ownership in these units is identical to that in Lots 3 and 4.

I will need answers to these questions in order to determine compliance of these applications with the requirements of which I previously advised you.

All of Section 24 is subject to an Operating Agreement covering depths from 2300 feet to 10,896 feet below the surface. Our records indicate Devon is the Operator.
