On September 1, 1966, we originally filed the attached C-101 and C-102, on the above well. You however rejected this application under Rule 104. We were fully aware of Rule 104, however we neglected to state the reason.

We would like to re-file this application and request an unorthodox location under Rule 104-F, based on topographical conditions, as follows.

First, we own all 40 acre tracts surrounding this location, all as to surface, water rights, and minerals. However this site is located in the Cimarron river bottom, and by going west - we would get into the old Cimarron River channel, which is very low ground and over flows quite often. As it is this location is on a high strip of ground which makes the location operable.

Later events have proven that this well has sufficient pressure to raise the fluids to within 120 feet of the top.

We mudded the hole up, set pipe, and pulled it out and found some gas, however it is mudded off at this time and will not flow. Application is hereby made to re-drill, clean out and test for oil and/or gas.
