Gentlemen:

We propose to drill a Mancos Formation test well in the west half of Section 27, Township 26 North, Range 1 West, Rio Arriba County. Because of the rough terrain in this area, we plan to drill the well at an unorthodox location. This location is 1415 feet from the south line and 740 feet from the west line of the section. A plat of the proposed location and a plat showing the topography are attached for your information.

All land within one mile of the location have been committed to the Canada Ojitos Unit.

We hereby request approval of the New Mexico Oil Conservation Commission that this well be drilled at the above described unorthodox location.






