

Gentlemen:

Shell Oil Company requests administrative approval for an unorthodox location for its Sanger Well No. 6 in the Hobbs, Grayburg-San Andres pool in Lea County, New Mexico under Rule 104 Section F of the Rules and Regulations of the Commission. Attached is the required form C-101 and certified plats. The proposed location is 1200 feet from the north line and 470 feet from the west line of Section 27, Township 18 South, Range 38 East, Lea County, New Mexico.


Administrative approval of this unorthodox location is requested as a special case of topographical conditions affecting the standard location. The standard location places the well immediately in front of the entrance to the main structure of a large shopping center planned at this site.

Proration Unit D, Section 27 which is to be dedicated to this well is within the city limits of the City of Hobbs and is crossed on the southwest corner by Turner Boulevard. The Northgate Development Company of Hobbs has completed the basic plans to utilize approximately 14 acres of this Unit D area fronting Turner Boulevard as the site of their new multi-million dollar mall-type shopping center. To avoid interference with this project and still take advantage of an optimum location for the No. 6 well, we request approval to move the location parallel to Turner Boulevard approximately 252 feet south-east. This is a nonstandard location in that it is 120 feet from the proration unit boundary on the south but is 470 feet from the nearest lease line.

Further, the remainder of the surface of the 40-acre proration Unit D of Section 27 is a developed residential area with private homes, commercial structures, and necessary utility installations. Therefore, in the interests of the public and the owners of the surface acreage, we request your administrative approval of the proposed unorthodox location.

Offset operators to this proration unit have been sent copies of this application.




