Continental Oil Company, as operator for the MCA Unit, hereby requests approval under the provision of Order No. R-2403-A to drill MCA Unit Well No. 266 at a location 1345' from the south line and 2615' from the west line (Unit K) of Section 20, T-17S, R-32E, Lea County, New Mexico.


As shown on the attached plat this location is 25' from the nearest quarter-quarter section boundary line. The well is being drilled in conjunction with our current in-fill drilling evaluation program, and should result in the more efficient recovery of oil in this immediate area.

Since this well is located at least 3/4 mile from the nearest outside boundary of the unit, it is respectfully requested that immediate approval of this location be given.



