MCA Unit Well No. 296, to be located 1400 feet from the South line and 2615 feet from the West line of Section 28;

MCA Unit Well No. 297, to be located 1345 feet from the South line and 1345 feet from the East line of Section 28; and

MCA Unit Well No. 298, to be located 1345 feet from the North line and 25 feet from the East line of Section 19.

By authority granted me under the provisions of Order No. R-2403, as amended by Order No. R-2403-A, the above-described unorthodox locations are hereby approved.
