



This letter shall serve to evidence the agreement between XTO Energy Inc. (XTO) and Manana Gas, Inc. (Manana), as follows:

XTO hereby agrees to drop protest of Manana's application for an unorthodox location for the Crooked Seams No. 2 Well, located in Section 14, T30N, R12W, San Juan County, New Mexico, said application for unorthodox location being set for hearing on August 31, 2006 at the offices of the New Mexico Oil Conservation Division.

In exchange for XTO's approval of the unorthodox location for the Crooked Seams No. 2 Well, Manana agrees to grant mutually acceptable well pad agreements with XTO for the Manana Bonnie No. 1 Well, located in Sec. 7 of T30N, R11W and the Manana Herrera No. 1 Well, located in Sec. 4 of T30N, R11W. The well pad agreements will provide that XTO will make any needed extensions or conditioning of the well pads at XTO's own expense. Additionally, the well pad agreements will provide for indemnification of Manana from any surface, equipment or other damages caused by XTO.

Additionally, Manana agrees not to protest any future application by XTO for an unorthodox location for a Fruitland Coal or Pictured Cliffs well location in Section 11, Township 30 North, Range 12 West, San Juan County, New Mexico, as long as any future application for unorthodox location by XTO is greater than 420' from the south line of Section 11.
