

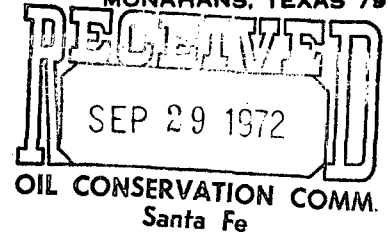

Wood, McShane & Thams request approval to drill New Mexico "M" State Nos. 65, 66, and 67 on unorthodox locations in the Langlie Mattix Pool. Commission Order No. R-3910, dated January 14, 1970, provides for administrative approval of wells to be drilled at orthodox and unorthodox locations within the "M" State Lease Waterflood Project, provided said wells are drilled no closer than 330 feet to the outer boundary of the subject lease nor closer than 10 feet to any quarter-quarter section or subdivision inner boundary.

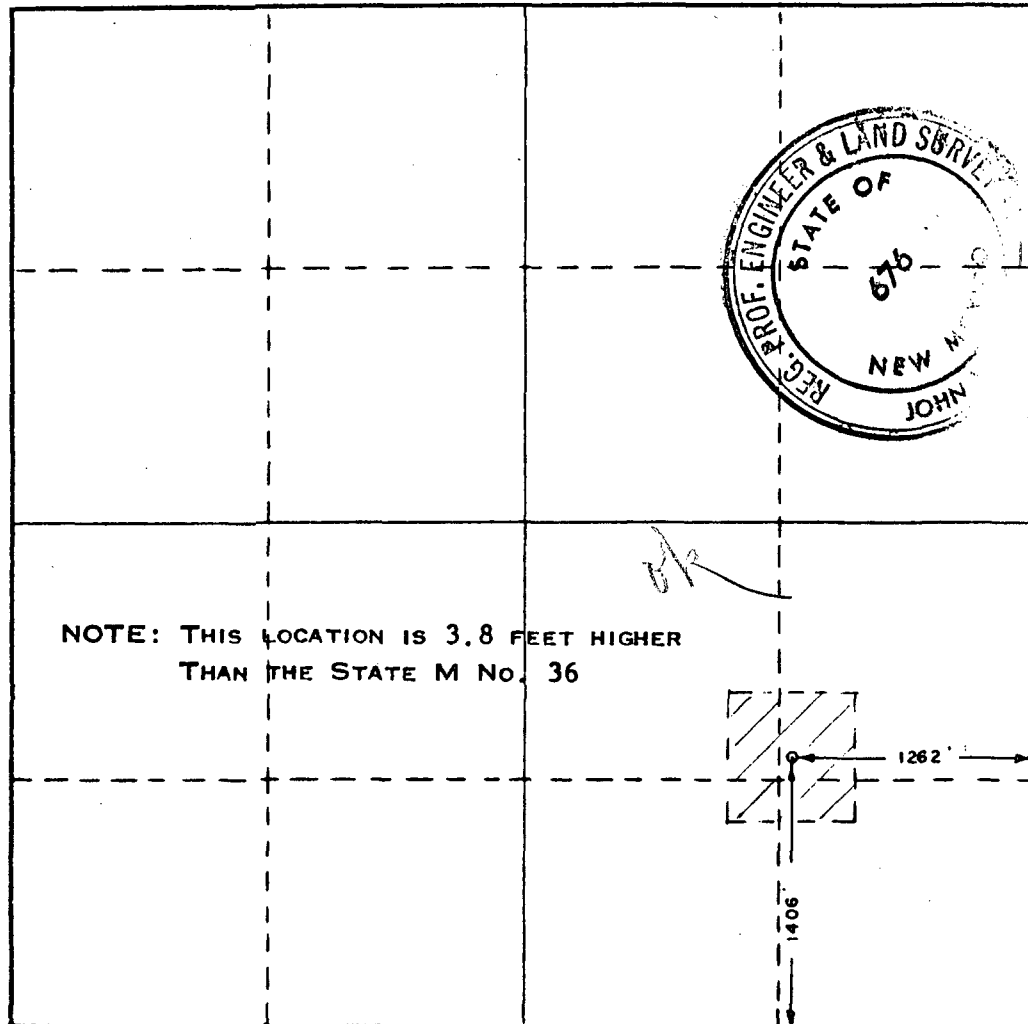

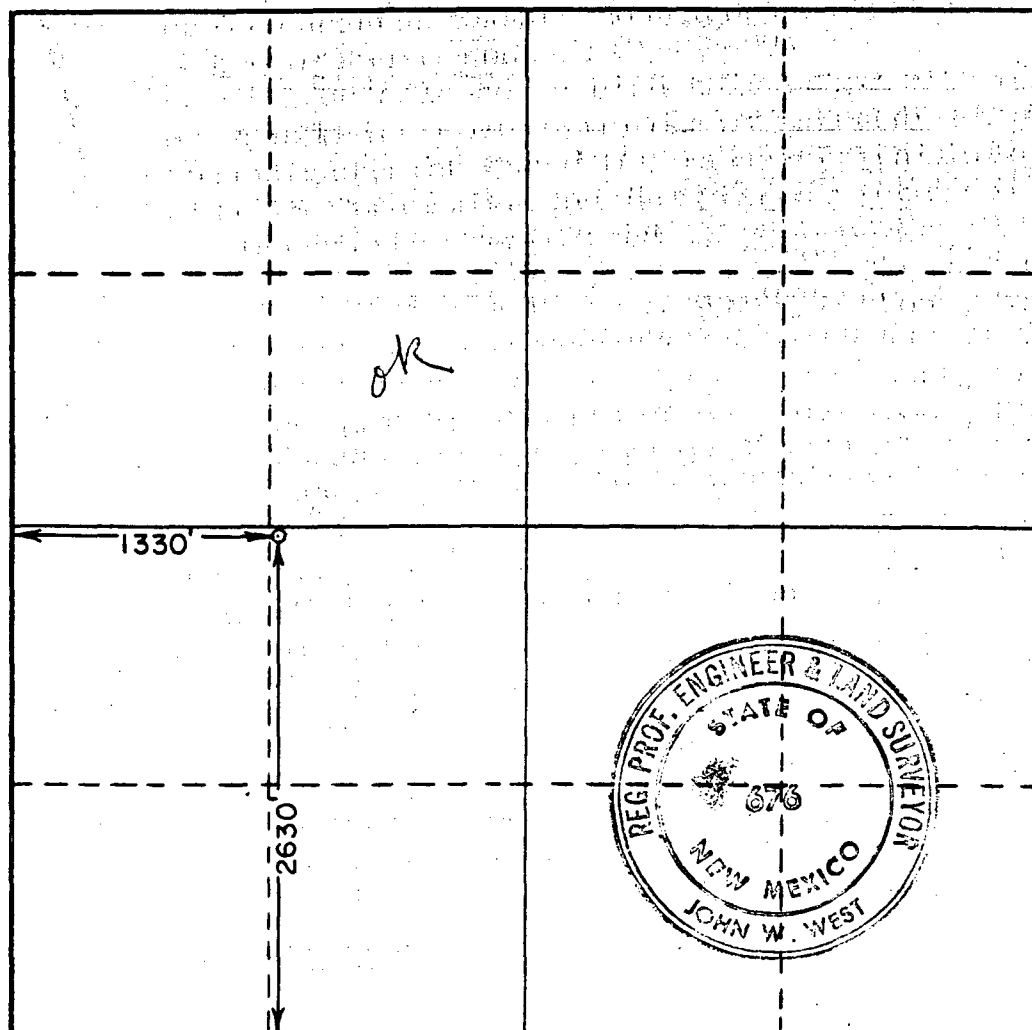
