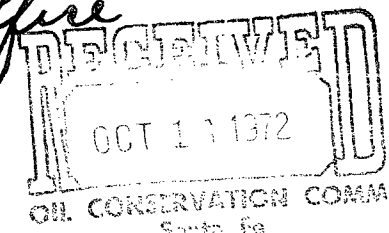

Gentlemen:

Skelly Oil Company respectfully requests administrative approval to drill a wildcat well to be located 2180' FNL and 1980' FWL of Section 10, T24S, R29E, Eddy County, New Mexico. Said well to be drilled through the Morrow Formation at approximately 13,000-13,500', from which gas production is anticipated.

Skelly is the owner of a lease in the North half (N/2) of Sec. 10-24S-29E, Eddy County; and the Statewide rules, and more particularly Rule 104-B-1(a), provide for Formation of Pennsylvanian age or older shall be located on a drilling tract consisting of 320 surface contiguous acres comprising any two contiguous quarter sections of a single governmental section, with minimum spacing of 660' to the nearest side boundary of the unit nor closer than 1,980' to the nearest end boundary.


The original planned location was to be 1980' FNL and 1980' FWL of Section 10, however, it has become necessary to move to location 200' south in order to avoid the extreme problems of topography.

Attached is a Well Location and Acreage Dedication Plat, along with a Land Plat indicating offset operators and a topography plat for Section 10.
