

Gentlemen:

Under the provisions of Rule 104(F), Mobil Oil Corporation respectfully requests authority to drill the subject well at an unorthodox location. Mobil is moving this well from an orthodox location at the request of the Bureau of Land Management because of a motorcycle race track in this area of Mobil's lease. This well was to be drilled 660 ft from the north line and 1980 ft from the east line of Sec. 8, T-21-S, R-27-E. Mobil now proposes to drill at a location 660 ft from the north line and 1650 ft from the east line of said Sec. 8.
