GEER & WILLIAMS COM WELL NO. 1
SECTION 34, T22S, R27E,
EDDY COUNTY, NEW MEXICO
SOUTH CARLSBAD MORROW FIELD

Gentlemen:

Mobil Oil Corporation respectfully requests authority to drill the subject well at an unorthodox location, due to topographical conditions, under the provisions of Rule 104 (F).

As shown on the attached plat, the proposed location is located 2509 feet from the north line and 1782 feet from the west line of Section 34, T22S, R27E, Eddy County, New Mexico. The subject well is proposed to be a single Morrow completion with the W/2 of said Section 34 dedicated to the well.

The proposed location is unorthodox because it is located 188 feet from the half-section line, rather than the minimum permitted 330 feet. The topographical conditions that exist in the west half of Section 34 are such that a combination of irrigation canals, planned irrigation flow patterns, alfalfa and cotton crops, and paved roads all dictate that an unorthodox location is recommended and necessary due to the land use.

The surface rights of the SE/4, NW/4 of said Section 34 are privately owned in fee by Mr. John Williams. Mobil originally staked the subject location at a standard position; however, after considerable negotiations we found that we would be unable to conclude an agreement with Mr. Williams on that location. The unorthodox location, as herein submitted, is located adjacent to the right-of-way of a paved road and appears to be the only acceptable position for a well site due to the land use.

The following items supporting this request are herein submitted in triplicate:

1. Form C-102 - Well Location and Acreage Dedication Plat.
2. Form C-101 - Application for Permit to Drill
3. Plat showing the topographical features and offset operators.
4. Copy of letter sent to each offset operator, by certified mail, requesting waiver of objection to the proposed unorthodox location.
5. Address list of the offset operators.
