



Dear Mr. Porter:

This is a request for administrative approval for an unorthodox gas well location in the Blanco Pictured Cliffs pool.

It is intended to locate the EPNG Com "K" No. 12 600' from the South line and 1790' from the East line of Section 32, T-29-N, R-9-W, San Juan County, New Mexico. The Southeast quarter of Section 32 is dedicated to this well.

An orthodox location in this quarter section would place the subject well on the side of a high and extremely rough canyon. If the well were drilled in an orthodox location, the roads and pipeline would be very expensive to build and maintain.

One of the offset proration units is operated by Tenneco Oil Company and another by Amoco Production. Both of these companies have been sent a letter advising them of our intentions subject to your approval.

Also attached you will notice is a plat showing the terrain features which make it necessary to apply for the unorthodox location.
