We respectfully request administrative action, subject to your receipt of waivers of objection or to the 20-day waiver waiting period, on our application for an unorthodox location for the captioned well in the Blinebry Gas Pool. This well is located in Unit L, 660 feet FW and 2050 feet FS Lines, and 590 feet FN Lines of the west half SW/4, Section 24, T-22-S, R-37-E. The 80-acre unit designated to this well is described as the west half SW/4 of the said section.

This well formerly was completed in the Tubb pool which has been temporarily abandoned, and has now been recompleted in the Blinebry reservoir. It is a replacement for Well No. 1 in which the Blinebry zone has been temporarily abandoned.
