Dear Mr. Ramey:

The above described well was drilled originally as a Bough "C" test. After production testing the Bough "C", the well proved to be non-commercial in that formation. Since that time we have plugged the Bough "C", reperforated and treated the ABO formation. Because this well was originally drilled as a Bough "C" test and the location is not within 200 feet of the center of the Southwest quarter (SW $\frac{1}{4}$), we respectfully request approval for a nonstandard location. Copies of this letter, forms 102,103,104, and a map of the acreage has been sent to all offset operators.


