UNORTHODOX WELL LOCATION MOBIL OIL CORPORATION'S BRIDGES-STATE, WELL NO. 86 UNDESIGNATED OUEEN GAS POOL LEA COUNTY, NEW MEXICO

Gentlemen:

Mobil Oil Corporation respectfully requests authority to recomplete the subject well at an unorthodox location under the provisions of Rule 104 F. Until recently Well No. 86 was completed as an oil well in the Vacuum (Grayburg-San Andres) Pool. This pay watered out and the well became uneconomical to produce (3 BO + 116 BW/day). It has been plugged back to the Queen zone (perforations 3902-3912) and completed as a small volume gas well. It is presently shut in pending Commission action on this request.

Well No. 86 is located in Unit Letter P, 330 ft from the south line and 330 ft from the east line of Sec. 3, T17S, R34E, Lea County, New Mexico. Since this well is less than 660 ft to the section line, as required by Rule 104 C II(a), this request is made.

Supporting documents being submitted in triplicate are:

- 1. NMOCC Form C-102 Well location and acreage dedication plat.
- 2. Certified plat showing the well location and offset operators.
- 3. List of offset operators.

By registered mail the offset operators are being furnished a copy of this letter and attachments as their notice of this application and request for their waiver of objection.


