This letter is in regard to the request for an unorthodox location on our Cossatot E #2 well located in Lea County, New Mexico, Section 13, Township 22-S, Range 37-E.

The enclosed location plat shows the original location of 990' from the South Line and 990' from the West Line to be staked at the intersection of two pipeline Right-of-Ways.

We respectfully request that permission be given to move this location 100' north, to safely be able to drill and complete this well. This would make our location distance 990' from the West Line and 1090' from the South Line. We should have no conflict of interest in this request because of our Cossatot H Lease being the north offset wells in the direction of this move.



All distances must be from the outer boundaries of the Section.



